## Increase in Share Capital of Delfi Foods Inc.

The Board of Directors of Petra Foods Limited (*Company*) wishes to announce that the Company has subscribed to an additional 22 million shares of par value of Philippines Peso 1 each in Delfi Foods Inc, a wholly-owned subsidiary in the Philippines for a cash consideration of Php 22 million (US\$530,000).
